Arizona Legislative Report

This week in Arizona, the deadline to introduce bills in both chambers has passed. There are a total of 1,138 bills and 83 resolutions circulating. Next week will be the final opportunity for bills to be heard in their chamber of origin so agendas were heavy this week and will continue to be next week.

The microbrewery battle progressed this week when one version, SB 1030 (microbreweries; multiple licenses; production; sales) sponsored by Sen. Kelli Ward (R- Lake Havasu City) passed out of the Commerce and Workforce Development Committee on Tuesday. After hours of debate the measure passed 6-2. Sen. Steve Smith (R- Maricopa) had a different bill to address the issue that was favored by the liquor distributors. Smith opted to hold his bill and asked the interested parties to continue to work together to find common ground.

Many were shocked this week when Superintendent of Public Instruction Dianne Douglas fired two high level Department of Education staffers over the Common Core dispute. Almost immediately, Governor Ducey reversed the decision and stated that Douglas did not have the legal authority to do so. Douglas responded by claiming that Ducey has a "shadow faction of charter school operators" who seek to move funds away from traditional public schools and accused the Governor of conspiring to bring down test scores so students will be incentivized to move to charter schools. Ducey's spokesman Daniel Scarpinato stated, "Governor Ducey is disappointed Superintendent Douglas has chosen this path. His office will continue working every day to improve educational outcomes for every Arizona child, and he hopes she joins that conversation."

On Tuesday Governor Doug Ducey announced that Greg McKay will be taking the helm of the Department of Child Services. McKay, who was the whistle blower on the over 6,000 uninvestigated Child Protective Services cases, is replacing Charles Flanagan. McKay is a former Phoenix PD detective and was Chief of the Office of Child Welfare Investigations throughout the crisis at CPS.

Senator Debbie Lesko's (R-Peoria) legislation targeting misleading marketing practices from roof top solar companies passed out of the Senate Water and Energy Committee this week. The bill requires companies to disclose total number of monthly payments and any other fees, a summary of maintenance and operating costs, potential tax obligations, any subsidies or incentives the solar system is taking advantage of, and any affect the panels might have on the owner's ability to sell his or her home. The bill passed with bipartisan support.

While the solar lobby argued that the industry is already regulated and the legislation would be a job killer, the utilities came out in support of the increased consumer protections. "They shouldn't need a law or finance degree to understand [solar leases]... We believe informed customers make the best decisions for themselves and their families." the APS lobbyist said.

With the Phoenix mayoral race rapidly approaching, many are speculating on Republican challengers to current Mayor Greg Stanton, a Democrat. A poll this week showed Stanton in a double digit lead over both rumored candidates Christine Jones and Phoenix City Councilman Sal DiCiccio.

Attached is your updated bill tracking list. Please take a look at HB2212, it looks concerning. Our friends at the League and the cities were neutral. HB2525 (board of adjustment; appeals) cruised out of the Committee of the Whole on Thursday, it should be up for a final vote in the House next week. I had several people from the cities compliment the Planner's amendment on 1072 dealing with exclusionary zoning (good work, team!)

Our turnout was abysmal when you consider that only 194 ballots were cast last year for our Board of Directors. Of our 1,200 members, LESS than 20 percent participated. Our polling numbers should be significantly higher, especially when the electronic ballots literally take two minutes to prepare and transmit.

This year, we have five Board of Director positions that will be elected by our membership. **Nominations are now open.** Voting will occur in late summer and the results will be announced at the State Conference in Tucson in early November. We strive to provide a ballot of members in good standing that provide planning representation across private, public and other entities; are geographically dispersed; and include a range of ages and cultures.
